## HELMET WARNING AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT PLEASE READ CAREFULLY BEFORE SIGNING

I understand and agree that skiing, snowboarding and related activities are dangerous and that injuries are common and ordinary occurrences during these activities. I agree to assume all risks of death or injury to any part of the user's body which may result from skiing, snowboarding and the use of the helmet.

I understand and agree that no helmet can protect the user against all foreseeable impacts to the head, and that skiing and snowboarding can expose the user to forces which exceed the limits of protection offered by this helmet. I understand that this helmet does not guard against injury to the neck, spine or any other part of the user's body, and that these limitations are inherent risks of any activity in which this helmet will be used.

This helmet must fit properly in order to maximize its performance, and I agree that this helmet has been properly fitted to me by the provider. All instruction on the use of the helmet has been made clear to me and I understand the function of the helmet. I warrant that the helmet is comfortably snug and when I fasten the chin strap and shake my head there is no significant movement of the helmet. I further warrant that I will be the only person using the helmet during this rental period.

If the helmet is damaged or involved in any kind of accident, I will immediately return it to the Bridger Bowl Ski Shop and report the accident or damage.

I understand I will be responsible for the replacement of the helmet at full retail value if it is not returned to the shop. I acknowledge it is my responsibility to return this helmet to the Bridger Bowl Ski Shop by the agreed upon date, in clean condition and agree to pay for any repairs in the event the helmet is damaged beyond normal wear and tear.
